During the reporting period, the following activities occurred: the Recovery Act Enhancement of the Collection of Forensic Evidence in Sexual Assault Cases Project hired a full time Forensic Interviewer to improve the collection of the forensic evidence in sexual assault cases; the Recovery Act Sex Offender Registry National Compliance Initiative Project hired a full time Case Manager to maintain Guam's Sex Offender Registry and to support the verification of the registered sex offenders; Recovery Act Criminal Justice Records Improvement Program contract with the vendor was signed for the implementation of a virtual Computer Criminal History, and Hot Files System; the Recovery Act Adult Drug Court Enhancement Project hired a full time Case Manager to oversee and manage the new clients entered into the program; and no activity occurred under the Recovery Act Street Violent Crime Prosecution Project and Recovery Act Criminal Sexual Conduct Prosecution Project. The Office of the Attorney General is working with the Department of Administration to recruit Attorney's for the project.
